

# SUMMARY OF THE MINUTES SAN JUAN COUNTY FIRE DISTRICT 3

Tuesday, December 12, 2023 – Fire Department Training Room

## **CALL TO ORDER**

Chair Cardinale called the Fire Commission meeting for SJC Fire District 3 to order at 3:00 p.m.

#### **ROLL CALL**

Commissioners Present: Frank Cardinale (Chair) and Warren Appleton (Member). Dwight Colley (Co-Chair) was absent. [Note: Commissioner Appleton submitted Oath of Office prior to the meeting.]

Staff: Interim Chief Noel Monin, Executive Staff Robin Garcia and Board Secretary Amy Taylor.

Others: SJI Fire & Rescue staff.

## CITIZEN COMMENTS / CORRESPONDENCE

No citizen comments or correspondence were presented.

#### **CONSENT AGENDA**

18 No changes were requested for the Consent Agenda.

Moved by Appleton, seconded by Cardinale, to approve the Minutes of November 14, 2023. Motion passed 2-0 with Colley absent.

Moved by Appleton, seconded by Cardinale, to approve the payment of Bills as published. Motion passed 2-0 with Colley absent.

Moved by Appleton, seconded by Cardinale, to approve the payment of Payroll as published. Motion passed 2-0 with Colley absent.

#### **OLD BUSINESS**

Budget Work Session - Interim Chief Monin explained that staff and the Commission held a budget work session on December 2, 2023 to adjust amounts for certain line items in the adopted 2024 budget. Adjustments highlights include:

General Fund - Redistributing some funds for personnel for an ending fund balance of \$304,023.

• Reserve Fund – Shifting funds for Fire Boat expenditures to the Capital Fund for an ending fund balance of \$169,264.

  LOSAP Fund – The reserves for future expenditures are virtually dormant with an ending fund balance of \$40,400. Interim Chief Monin explained that the program was designed for paydown then closure. Some participants opted for payout while others left funds in reserves to accrue interest. Discussion followed regarding whether to take steps to cash out participants and close the LOSAP fund permanently.

Moved by Appleton, seconded by Cardinale, to adopt the budget amendments as presented. Motion passed 2-0 with Colley absent.

## 43 STAFF REPORTS

Interim Chief Monin reviewed the monthly financial report, including general fund revenues, expenses, ending cash balances and anticipated revenues. The Commissioners requested that LOSAP funds be removed from the new report format and tracked as a separate item.
