- under peer review by the District Policy Committee pursuant to the Lexipol Solutions subscription (standardized 48
- public safety and risk pool policies). Chief Monin recommended that the review process for policies be (1) the Policy

Committee provides peer review, (2) Chief reviews and makes recommendation to Commission, and (3) Commission adopts, modifies or rejects. Chair Colley requested that a written policy for said work flow be presented at the regular September 2024 meeting.

#### Lease Review – Fire Boat

Chief Monin requested permission to seek relocation of the fire boat. The boat is currently located near Port of Friday Harbor C dock. The current location of the boat is heavily trafficked, exposed to public (less secure), has poor storage capabilities and poses parking and other issues for volunteers attempting to respond to emergencies in a time-efficient manner. If an emergency were to occur, logistics at the Port and/or downtown could delay or make response impossible. Discussion followed regarding discretion, privacy and accessibility issues. Consensus to seek alternatives marinas with the Port of Friday Harbor, including relocation to Jensen Shipyard.
